# BYLAW # 2024 – 007 Campground Bylaw

# A BYLAW OF THE VILLAGE OF ANDREW, IN THE PROVINCE OF ALBERTA, TO ESTABLISH RULES, REGULATIONS AND FEES FOR THE OPERATION OF THE VILLAGE OF ANDREW CAMPGROUND

WHEREAS, the Council of the Village of Andrew, in the Province of Alberta, under the authority of the Municipal Government Act, Chapter M-26, as amended, may pass bylaws for regulating and operating a municipal campground.

**NOW THEREFORE**, the Council of the Village of Andrew, in the Province of Alberta, duly assembled, **HEREBY ENACTS AS FOLLOWS:** 

## **DEFINITIONS**

"Campground" means the areas so designated in the Village of Andrew located at 5318 49A Avenue.

"Camp Site" means the stall in which a Recreation Unit is parked or a tent is placed and shall also be referred to as Site.

"Patron" means the individual(s) using a Camp Site in the Campground.

"Recreation Unit" means a duly licensed motorhome, trailer or 5<sup>th</sup> wheel, slide in camper or chassis mounted camper but does not include a tent.

"Showers" means the shower and washroom building located at the Campground.

"Tent" means a collapsible moveable shelter consisting of a tough fabric or plastic cover held up by poles and kept in place by ropes and pegs.

"Village Office" means the Village of Andrew municipal administration building located at 5021 50 Street.

"Washroom" means the shower and washroom building located at the Campground.

## DATES OF OPERATION

1. The Chief Administrative Officer of the Village of Andrew shall designate opening and closing dates depending on weather. Typical opening date will be May long weekend and typical closing date will be mid to late October.

#### REGISTRATION

- 2. All units must be registered in advance of being able to access a site at the campground by completing a Campground Registration Form.
- 3. Registration shall be made through the Village Office during operational hours.
- 4. If registration is required outside of Village Office hours, patrons must call 780-203-6713. Only credit or debit payments, or exact cash, will be accepted for registrations accepted outside of Village Office Hours.
- 5. Village staff shall be responsible for granting access to a reserved and paid Camp Site.
- 6. Sites numbered 2 through 11 have access to water, sewer and power (full service).
- 7. Sites numbered 12 through 21 have power only.

#### FEES

- 8. Fees shall be \$35 per night for full service.
- 9. Monthly fees shall be \$750 for full service.
- 10. Fees shall be \$25 per night for power only.
- 11. Monthly fees shall be \$450 for power only.
- 12. Fees shall be \$10 per night for each Unit or Tent, in the un-serviced area.

# REGULATIONS

- 13. All pets must be kept on a leash at all times and under the control of their owner as per the Village of Andrew Responsible Pet Ownership Bylaw.
- 14. Quiet hours are in effect from 11:00 PM to 7:00 AM every day.
- 15. No animals are permitted in the shower/washrooms.
- 16. Campsites must be kept neat and tidy at all times.
- 17. The CAO or their designate and/or a Peace Officer, and/or the RCMP may use their discretion to refuse admittance or cancel access to any patron(s) and request patron(s) vacate the Campground if found to be in contravention of any section or part of this Bylaw.

- 18. Showers and washrooms are available to Patrons by being provided with an access code upon registration.
- 19. Check out time is 12:00 PM.

## **ENFORCEMENT**

20. The Bylaw Officer, Peace Officer and the RCMP may enforce this bylaw by such measures as deemed necessary to ensure the Bylaw is complied with including having the right to enter the premises/and or property it deemed necessary.
