BYLAW NO. 2005-02

A BYLAW OF THE VILLAGE OF ANDREW, IN THE PROVINCE OF ALBERTA, TO ESTABLISH THE POSITION OF DESIGNATED OFFICER

2. That this bylaw is effective upon the date of its third and final reading.



A BYLAW OF THE MUNICIPALITY OF _____, IN THE PROVINCE OF ALBERTA, TO ESTABLISH THE POSITION OF DESIGNATED OFFICER


WHEREAS pursuant to the provisions of section 210 of the Municipal Government Act, the Council may pass a bylaw to establish one or more positions to carry out the powers duties and function of a designated officer.

NOW THEREFORE, the Council of the Municipality of _____ in the Province of Alberta, duly assembled, hereby enacts as follows:

1. That the position of Assessor be established to carry out the duties of an assessor as designated in the Municipal Government Act.
2. That this bylaw is effective upon the dated of its third and final reading.

Appointment of assessor

Section 284(1)(d) of the MGA defines an assessor as a person who has the qualifications set out in the regulations and is appointed by a municipality to the position of designated officer to carry out the duties and responsibilities of an assessor under the MGA. Once a bylaw establishing the position of Assessor as a designated officer is passed, a specific individual may be appointed to the position in one of two ways;

1. a council may appoint an individual to the position of Assessor by a resolution,
or,

2. the Chief Administrative officer, if given authority by council, may appoint an individual to the position of Assessor.

In the case of a municipality receiving assessment services from a private firm, another municipality or a regional services commission, the individual appointed as assessor should normally be the individual that handles the majority of the municipality's assessment roll, or his or her supervisor or manager.
