Whereas, application has been made to the council to have the highway closed, and

Whereas, notice of intention of the council to pass a by - law has been (served/mailed by registered mail) to persons registered or assessed as owners of the land abutting upon the portion of the highway so proposed to be closed at least two weeks before the date fixed for the passing of the bylaw;

Whereas, notice of intention of the council to pass a by - law has been publish in the Vegreville News Advertiser - newspaper circulating in the municipality on January 30, 1995 and on February 13, 1995 the last of such publications being at least two weeks before the day fixed for the passing of the bylaw and

Whereas, Council was petitioned by the Andrew Rainbow Club stating that they would be prejudicially affected by the bylaw but subsequently withdrew the petition when Council clarified the closure for the Club's executives at Council's regular meeting on February 22, 1995

Now therefore, be it resolved that the Council of the Village of Andrew does hereby close the following described highway, subject to rights of access granted by other legislation or regulations; the undeveloped lane described as: Firstly: Plan 3472H.W., all of the lane. Secondly: Plan 6308K.S., the lane corner cut-off adjoining the South East corner of Lot 16 Block 7.
