BYLAW NO. 94-14

WHEREAS, the Municipal Council of the Village of Andrew, in the Province of Alberta, has the authority to implement a Traffic Bylaw in accordance with the Highway Traffic Act and the Municipal Government Act, being Chapter H-7 and Chapter M-26 respectively of the Revised Statutes of Alberta, 1980, and amendments thereto; and

WHEREAS; the Municipal Council deems it necessary to provide such a Bylaw; and

NOW THEREFORE; the Council of the Village of Andrew, in the Province of Alberta, duly assembled enacts the following:

101. This Bylaw may be cited as the "Village of Andrew Traffic Bylaw".
102. Wherever in this Bylaw the following terms are used, unless the context otherwise requires, they shall have the meanings ascribed to them in this Bylaw.
103. Wherever in this Bylaw the following terms are used, unless the context otherwise requires, they shall have the meanings ascribed to them in this section.

PART I - DEFINITIONS

Bicycle		"Bicycle" means a cycle propelled by human power on which a person can ride, regardless of the number of wheels it has, and includes a vehicle that, <ol style="list-style-type: none">i) may be propelled by muscular power,ii) is fitted with pedals that are continually operable to propel it.
Boulevard	2.	"Boulevard" means that part of a highway that <ol style="list-style-type: none">i) is not roadway, andii) is that part of the sidewalk that is not especially adapted to the use of or ordinarily used by pedestrians.
Bus	3.	"Bus" shall mean a bus owned or operated by a company or person(s) holding a special franchise by the Town.
Bus Stop	4.	"Bus Stop" shall mean that portion of a street designated by a sign and/or curb marking for the purpose of loading or unloading passengers for use by a company of person(s) holding a special franchise authorized by the Town.
Cul-de-sac	5.	"Cul-de-sac" shall be defined as 51A ave and 48th street or a deadend street.
Central Business District	6.	"Central business district" shall be that area of the Village along 50th avenue and 51st street.
Center Line	7.	"Center Line" means, <ol style="list-style-type: none">i) the center of a roadway measured from the curbs or, in the absence of curbs, from the edges of the roadway,ii) in the case of a highway designated by traffic control devices<ol style="list-style-type: none">a. as an offset center highway, orb. as a highway having a certain number of traffic lanes for traffic moving in a certain direction at all times or at specified times, the lane dividing the lanes for traffic moving in opposite directions, or

- iii) in the case of a divided highway, that portion of the highway separating the roadways for traffic moving in opposite directions.
- Commercial Vehicle 8. "Commercial Vehicle"
- i) means a truck, trailer or semi-trailer, except
- a. a truck, trailer or semi-trailer that is a public service vehicle or,
- b. a truck, trailer or semi-trailer or any class of vehicle that by regulations or by an order of the Alberta Motor Transport Board is exempted from being classified as a commercial vehicle, and
- ii) includes,
- a. a motor vehicle from which sales are made of goods, wares, merchandise or commodity, and
- b. a motor vehicle by means of which delivery is made of goods, wares, merchandise or commodity to purchase of consignee thereof.
- Council 9. "Council" means Council of the Village of Andrew.
- Crosswalk 10. "Crosswalk" means
- i) that part of a roadway at an intersection included within the connection of the lateral line of the sidewalk on opposite sides of the highway measured from the curbs or, in the absence of curbs, from the edges of the roadway, or
- ii) any part of a roadway at an intersection or elsewhere distinctly indicated for pedestrian crossing by signs or by lines of or by other markings on the road surface.
- Curb 11. "Curb" means the actual curb or division point between that portion of the street intended for the use of vehicles and that portion intended for the use of pedestrians.
- Double Parking 12. "Double parking" shall mean the parking of a vehicle on a street parallel to a vehicle parked beside the curb in a parking area, or parking to the rear of any vehicle that is angle parked at the curb in a parking area.
- Driver or Operator 13. "Driver" or "Operator" means a person who drives or is in the actual physical control of a vehicle.
- Heavy Vehicle 14. "Heavy vehicle" means:
- a. a vehicle with or without load weighing five thousand (500) kilograms or more, or exceeding eleven (11) meters in length.
- b. a vehicle with a trailer with or without load which exceeds five thousand (5000) kilograms in total weight of eleven (11) meters in total length.

- Highway
15. "Highway" means any thoroughfare, street, road, trail, avenue, parkway, driveway, viaduct, lane, alley, square, bridge, causeway, trestleway, or any other place, whether publicly or privately owned, any part of which the public is ordinarily entitled to permitted to use for the passage or parking of vehicles and,
- i) includes
 - a. a sidewalk (including the boulevard portion of the sidewalk),
 - b. if a ditch lies adjacent to and parallel with the roadway,the ditch, and
 - c. if a highway right of way is contained between fences of between a fence and one side of the roadway as the case may be, but
 - ii) does not include a place declared by the Lieutenant Governor in Council not to be a highway.
- Holiday
16. "Holiday" means
- a. New Year's Day
 - b. Family Day
 - c. Good Friday
 - d. Victoria Day (the first Monday immediately preceding the 25th of May in each year)
 - e. Canada Day
 - f. Annual Civic Holiday as proclaimed by the Mayor and Council
 - g. Labor Day (first Monday in September)
 - h. Thanksgiving Day (second Monday in October)
 - i. Remembrance Day
 - j. Christmas Day
 - k. The 26th day of December or when such day falls on a Sunday, then the 27th day of December, of when such day falls on a Monday, then the 28th of December, (usually known as Boxing Day).
 - l. Sunday
 - m. or any other days that may be designated as a holiday by the Mayor and Council.
- Implement of Husbandry
17. "Implement of husbandry" means a vehicle designed and adapted primarily for agriculture, horticulture, or livestock raising operations.
- Intersection
18. "Intersection" means the area embraced within the prolongation or connection of
- i) the lateral curb lines or, if none,
 - ii) the exterior edges of the roadways of two of more highways which join one another at an angle whether or not one highway crosses the other.

Laned Street	19.	"Laned street" means a street divided into two or more lanes for vehicle traffic.
Licensed Gross Vehicle Weight	20.	"Licensed gross vehicle weight" shall mean the gross weight for which a vehicle or truck is licensed or registered under the provisions of the Highway Traffic Act and/or The Motor Vehicle Administration Act for The Province of Alberta.
Loading Zone	21.	"Loading zone or unloading zone" means a space on the vehicle portion of the highway, marked with a sign authorized by this Bylaw permitting the parking therein for the purpose of loading or unloading passengers, or merchandise.
Median	22.	"Median" means a physical barrier or area that separates traffic travelling in one direction from traffic travelling in the opposite direction on a highway.
Moped	23.	"Moped" means a vehicle , regardless of the number of wheels it has, that <ol style="list-style-type: none">may be propelled by muscular or mechanical power,is fitted with pedals that are continually operable to propel it,weighs more than 34 kilograms but less than 55 kilograms,has a motor that is driven by electricity or has an engine displacement of not more than 50 cubic centimeterhas no hand-operated or foot-operated clutch or gearbox driven by the motor transferring power to the driven wheel, anddoes not have sufficient power to attain a speed greater than 50 kilometers per hour on level ground within a distance of two kilometers from a standing start.
Motorcycle	24.	"Motorcycle" means a motor vehicle mounted on 2 or 3 wheels and includes those motor vehicles known to the trade as motor cycles and scooters but does not include an off-highway vehicle as defined in the Off-Highway Act.
Motor Vehicle	25.	"Motor vehicle" means, <ol style="list-style-type: none">a vehicle propelled by any power other than muscular power, ora moped but does not include a bicycle, an aircraft, a tractor, whether equipped with rubber tires or not, an implement of husbandry or a motor vehicle that runs only on rails.
Off-Highway Travel	26.	"Off-highway vehicle" means any motorized vehicle designated for cross-country travel on land, water, snow, ice, marsh, or swamp land or on other natural terrain and without limiting the generality of the foregoing includes, when designed for such travel. <ol style="list-style-type: none">4-wheel drive or low pressure tire vehicles,motorcycles and related 2-wheel vehicles,amphibious machines

Operator	27.	"Operator" means a person who drives or is actual physical control of a vehicle.
Owner	28.	"Owner" means
	a.	in the case of land, any person who is registered under the Land Titles Act as the owner of land, or
	b.	in the case of property other than land, any person who is in lawful possession thereof, or
	c.	in the case of vehicles, "owner" includes any person renting a motor vehicle or having the exclusive use of it under a lease or otherwise for a period of more than 30 days.
Parade or Procession	29.	"Parade or procession" shall mean any group of pedestrians marching or walking on any street and numbering twenty-five (25) or more (except members of the Armed Forces) and/or of vehicles numbering seven (7) or more and proceeding under common leadership (except funeral processions and military parades).
Park	30.	"Park" when prohibited, means allow a vehicle (whether occupied or not) to remain standing in one place, except
	i)	when standing temporarily for the purpose of and while actually engaged in loading of unloading passengers,or
	ii)	when standing in obedience to a peace officer or traffic control device.
Parking Lot	31.	"Parking Lot" means a lot or portion of a lot whether publicly or privately owned any part of which the public is ordinarily entitled to use for the purpose of parking vehicles.
Parking Stall	32.	"Parking stall" means a portion of a street or parking lot indicated by markings as parking space for one vehicle.
Passenger Zone	33.	"Passenger zone" means an area or space on a street established for the loading and unloading of passengers only.
Peace Officers	34.	"Peace Officers" means
	i)	a member of the Royal Canadian Mounted Police
	ii)	a member of a municipal police service,
	iii)	a special constable.
Pedestrian	35.	"Pedestrian" means a person on foot or a person in a wheel chair.
Secretary-of Treasurer	36.	"Secretary-Treasurer" means the Municipal Administrator of the Village Andrew.

Sign	37.	"Sign" means a "traffic control device" as defined.
Skateboard	38.	"Skateboard" means a device for coasting made of a board mounted on coasters or wheels, commonly called a "skateboard" or other wheeled conveyances.
Tank Vehicle	39.	"Tank vehicle" means any vehicle other than railroad tank cars and boats with a cargo tank mounted thereon or built as an integral part thereof used for the transportation of flammable liquids or hazardous chemicals. Tank vehicles include self-propelled vehicles, and full trailers and semi-trailers without motive power and with wheels carrying either part or all of the load.
Time	40.	"Time" means either Mountain Standard Time or Mountain Day Light Savings Time, whichever is proclaimed to be in effect by the Province of Alberta.
Traffic Control Device	41.	"Traffic control device" means any sign, signal marking or device placed Device marked or erected under the authority of the Highway Traffic Act Chap.H-7 RSA 1980 for the purpose of regulation, warning or guiding traffic.
Traffic Control Signal	42.	"Traffic control signal" means a traffic control device whether manually, electrically or mechanically operated, by which traffic is directed to stop and to proceed.
Trailer	43.	"Trailer" means a vehicle so designed that it may be attached or drawn by a motor vehicle and intended to transport property or persons and includes any trailer that is designed, constructed and equipped as a dwelling place, living abode or sleeping place, either permanently or temporarily, but does not include machinery or equipment used in the construction of maintenance of highways.
Truck Tractor	44.	"Truck tractor" means a truck that is designed primarily for drawing another vehicle and is not designed to carry any load other than part of the weight of the vehicle drawn and includes a vehicle that is designed to accommodate a 5th wheel coupling, but does not include a crane equipment breakdown vehicle.
Vehicle	45.	"Vehicle" means a device in, on or by which a person or thing may be transported or drawn on a highway.
Village	46.	"Village" means the Village of Andrew.
Village Administrator	47.	"Village Administrator" means the Village Administrator of the Village of Andrew.

| Exempt Class of Vehicles | 201. | The Council may by resolution exempt any class of vehicle from such provisions of this Bylaw relating to parking and stopping as the Council may deem fit and under such conditions as the Council may impose, and may provide for the identification of such vehicles so exempted. |
| Placing of Traffic Signs | 202. | The Council may by resolution prescribe where traffic signs for controlling and regulating traffic in public places are to be located, and delegate to the Village Administrator the power to prescribe where traffic control devices are to be located with a record of such locations to be kept and which shall be open to public inspection during normal business hours. |
| Designate Highways | 203. | The Council may by resolution designate any highway as one to be divided into traffic lanes. |
| Impounding of Vehicles | 204. | Any Peace Officer appointed pursuant to the provisions of the Police Act being Chap.P-12.01 Revised Statutes of Alberta 1980 or By-law Enforcement Officer appointed pursuant to section 111.1 of the Municipal Government Act, being Chap.M26 of the Revised Statutes of Alberta 1980, or Special Constable appointed pursuant to Section 42 of the Police Act being Chap.P-12.01, Revised Statutes of Alberta 1980 may cause a vehicle or trailer to be removed and taken to and stored in a suitable place in accordance with Statutes of Alberta, 1980 and amendments thereto and all costs for removal and storage are in lien upon the vehicle or trailer. |
| Release of Impounded Vehicles | 205. | No impounded vehicle or trailer shall be released to its owner or his agent until the impounded charge and removal charge on the vehicle or trailer have been paid. Such charges shall be in addition to any fine or penalty imposed in respect of any such violation, or any payment made in lieu of prosecution as hereinafter provided. |
| Placing of Snow Cleaning Signs | 206. | Notwithstanding anything contained herein, in snow removal or highway cleaning operations carried on by Village employees or their contractors, the Village may tow or remove vehicles or trailers from the highway being cleaned or from which the snow is being removed, only after such highways have been posted with signs at least 12 hours prior to work commencing, and park same on an adjacent highway without impounding the vehicle or trailers. |

Removal of Obstructions	207.	<ol style="list-style-type: none">1. Only the Council and a Peace Officer may cause the removal of any unauthorized structure other thing which projects into or obstructs the use of any highway, sidewalk or boulevard.2. The charges for removal and storage of any such structure or other thing shall be in addition to any fine or penalty imposed or any payment in lieu of prosecution under Schedule "B" of this Bylaw.
Trees Obstructing Driver's View	208.	If the council is satisfied that any tree, hedge or shrub heretofore or hereafter planted on private property, interferes with or obstructs the view of the driver of any vehicle, they may require the owner, by giving seven (7) days notice by registered mail, to remove, prune, trim or alter such tree, hedge or shrub, and if the owner does not eliminate the obstruction within (7) days, the Council may direct the work done, and full cost therefore be added to the property in the form of a tax.
Penalties	209.	<ol style="list-style-type: none">1. The penalty amounts specified in Schedule "B" of this Bylaw are hereby established as the penalties for offences under this Bylaw.2. Specified penalties may be amended by the Council of the Village of Andrew.
Amend Penalties		
Violators	210.	Any person who violates the provisions of this Bylaw is guilty of an offence and liable to the penalties specified in this Bylaw.
Violation Tickets	211.	A violation ticket having a printed wording approved by the Council of the Village of Andrew may be issued by a Peace Officer, Special Constable or By-law Enforcement Officer to any person alleged to have committed an offence under this Bylaw and the said violation ticket shall require the payment to be made to the Municipal Administrator of the amount specified for that particular offence, and shall state the time within which such payment shall be made.
Payment of Ticket	212.	<ol style="list-style-type: none">1. A person to whom a violation ticket has been issued may pay the penalty therein specified within the time stated thereon.2. Should a person not pay the penalty within the specified time and prosecution has been entered against him, he shall be liable on summary conviction to pay the minimum fine equal to the penalty stated in the said violation ticket, plus the sum of Thirty Dollars (\$ 30.00) as costs and in default of payment, imprisonment for a period not exceeding thirty (30) days.
Prosecution for Non-payment		
Impound Bicycles and Skateboards	213.	Notwithstanding any other penalty that may be provided by Bylaw, a By-Law Enforcement Officer or Special Constable or Peace Officer is hereby authorized to impound any bicycle and/or skateboard operated in contravention to the provisions of this Bylaw for a period not to exceed fourteen (14) days.

Expense for Removal of Objects	214.	Any expenses incurred by the Village of Andrew for the removal of any obstruction on a highway placed thereon in contravention of this Bylaw may be recovered by distress upon the goods and chattels of the person by whom, or by whose direction, an obstruction is so placed in the same manner as if such expenses were taxes levied pursuant to the Municipal Taxation Act and so recoverable.
Serving Violation Tickets	215.	<p>A violation ticket shall be deemed to be sufficiently issued and served if:</p> <ol style="list-style-type: none">1. served on the accused personally, or2. mailed to the address of the registered owner of the vehicle or property concerned, or to the person concerned, or3. attached to or left upon the vehicle in respect of which the offence is alleged to have been committed.
Defending Charge	216.	<p>Nothing in Sections 209 and 215 shall:</p> <ol style="list-style-type: none">1. prevent any person from defending a charge of committing a breach of this Bylaw,2. prevent any Peace Officer or other person from laying any information against any other person, whether or not such person has made a payment under the provisions of Sections 209 and 215 for violation of any of the provisions of this Bylaw.
Responsible for Moving	217.	The Village of Andrew will not be responsible for any impounding or towing charges levied against a vehicle removed from a highway or parking lot pursuant to this Bylaw.
Chalk Marks	218.	<p>Chalk <u>Marking</u> of Tires Permitted</p> <p>In enforcing the provisions of this Bylaw, a Peace Officer or By-law Enforcement Officer is hereby authorized to place a chalk mark on the road face of the tire of a parked vehicle without that persons or the Village incurring any liability for doing so.</p>
Owner Responsibility	219.	Where a vehicle is driven, used, parked or left in contravention of any provision of this Bylaw, the owner or operator of the vehicle is responsible for the contravention and liable to the penalty provided herein, unless he proves to the satisfaction of the Court trying the case that at the time of the contravention the vehicle was not driven, used, parked or left by him or by any other person with his consent, expressed or implied.

| Care & Safety of Pedestrians | 304. | | At a place where there is a crosswalk a pedestrian has the right of way over vehicles for the purpose of crossing a highway within the crosswalk unless otherwise directed by a Peace Officer or a traffic control signal, but nothing in this section relieves a pedestrian from the duty of exercising due care for his/her own safety. |

Where to Stand	307.	A pedestrian waiting for a traffic control signal to change shall not stand on the highway.
Groups Standing	308.	No persons shall obstruct or prevent other persons using such highway or sidewalk and forthwith after a request has been made by a Police Officer or other person duly authorized to do so shall disperse and move away.
Sitting on Road	309.	No person shall stand, sit, or lie on any highway in such a manner as to obstruct vehicular or pedestrian traffic or as to annoy or incommode any other person lawfully upon the highway.
Hitchhiking	310.	No person shall stand upon, or walk along a highway for the purpose of soliciting a ride from the driver of any vehicle.
Watching Parade	311.	Nothing in section 308 and 309 shall be construed as prohibiting the assembling of persons for the purpose of watching a parade or procession duly authorized by the Council.

PART IV - PARKING

Parking Not Permitted	401.	Unless required or permitted by a traffic control device or signal or in compliance with the direction of a Peace Officer or to avoid conflict with other traffic, a driver shall not stop or park his/her vehicle: <ol style="list-style-type: none">1. on a sidewalk or boulevard, or2. on a crosswalk or any part of crosswalk, or3. within an intersection, or4. at an intersection nearer than five (5) meters to the projection of the corner property line immediately ahead or immediately to the rear except when his/her vehicle is parked in a space where a traffic control device indicates parking permitted, or5. within five(5) meters of any "Stop" sign or "Yield" sign, or6. within five (5) meters of any fire hydrant or when the hydrant is not located at the curb within five (5) meters of the point on the curb nearest the hydrant, or7. in such a manner as to obstruct access to a garage, private road or driveway or a vehicle crossway over a sidewalk, or8. within five (5) meters of the nearest side of a marked crosswalk, or9. along side or opposite any street excavation or obstruction when stopping or parking would obstruct traffic, or10. on any bridge or on the approach thereto, or11. at any place where a traffic control prohibits stopping or parking

402. 1. Section 401 shall not apply to vehicles owned or leased by the following corporations, companies, or police forces during such times as the operators of such vehicles are occupied on duties arising out of their employment that necessitates the parking of vehicles in the areas mentioned:
- a. Village of Andrew
 - b. Royal Canadian Mounted Police
 - c. School Buses, during such time that such buses are being used to transport students to and from the school and loading/unloading such students
 - d. Funeral cars owned and being operated by a Funeral Chapel in the course of performing a funeral.

2. Section 401 shall not apply to vehicles owned or leased by the following companies or individuals when there is an emergency situation:
- a. Alberta Power
 - b. Northwestern Utilities Ltd.
 - c. Medical Doctors and ambulances.
- No Parking Vehicle Over 6.0 Meters 403. 1. No person shall park any vehicle or trailer which singly or together exceeds six (6) meters in overall length upon any highway within a residential area.
- No Parking Vehicles Over 7.5 Meters 2. No person shall park any vehicle or combination of vehicles which singly or together exceed 7.5 meters in overall length in any area or zone where parallel parking is permitted, subject however to the proceeding prohibition regarding parking in residential areas.

PART XI - PENALTIES

1101. A person to whom a violation ticket has been issued may pay the penalty therein specified within the time stated thereon.
1102. Except as otherwise provided herein, any person violating any of the provisions of this Bylaw or any other person responsible for such violation shall be liable on summary conviction before a Provincial Judge or any Justice of the Peace having jurisdiction therein, to a penalty not exceeding five hundred dollars (\$500.00) exclusive of costs, or in case of non-payment of fine and costs imposed to imprisonment for any period not exceeding sixty (60) days unless such fines and costs, including the costs of committal are sooner paid.
1103. If any person is in default in doing any matter or thing directed by this Bylaw to be done, the matter or thing may be done by the Village at the expense of the person in default and the Village may recover the expenses thereof with costs by action in any Court of competent jurisdiction.
1104. Unless otherwise provided all penalties related to this Bylaw shall be as prescribed and set out in Schedule "B" attached hereto and forming part of this Bylaw. The penalties for any offenses not covered by Schedule "B" to this Bylaw shall be prescribed by the appropriate sections of the Highway Traffic Act and the related schedules of the Provincial Offenses Procedure Act.

PART XII - TRANSITIONAL

1201. 1. Where proceedings for an offence against this Bylaw were commenced before the coming into force of this Bylaw, the offence shall, after the coming into force of this Bylaw, be dealt with, inquired into, tried and determined in accordance with this Bylaw, and penalty, forfeiture or punishment in respect of that offence shall be imposed as if this Bylaw had not come into force, but where, under this Bylaw, forfeiture or punishment in respect of the offence is reduced or mitigated in relation to the penalty, forfeiture or punishment that would have been applicable if this Bylaw had not come into force, the provisions of this Bylaw relating to penalty, forfeiture and punishment shall apply.
2. Where proceedings for an offence against this Bylaw are commenced after the coming into force of this Bylaw the following provisions apply, namely:
 - a. the offence, whenever committed, shall be dealt with inquired into, tried and determined in accordance with this Bylaw;

b. if the offence was committed before the coming into force of this Bylaw, the penalty, forfeiture of punishment to be imposed upon conviction for that offence shall be the penalty, forfeiture of punishment authorized or required to be imposed by this Bylaw or by the law that would have applied if this Bylaw had not come into force, whichever penalty, forfeiture or punishment is the less severe; and
- c. if the offence is committed after the coming into force of this Bylaw, the penalty, forfeiture or punishment to be imposed upon conviction for that offence shall be the penalty, forfeiture of punishment authorized or required to be imposed by this Bylaw.

PART XIII - MARGINS

1301. Notations and words in the margin of this Bylaw are for convenience only and do not form part of this Bylaw.
