

**BYLAW NO. 97-03**

**BEING A BYLAW OF THE VILLAGE OF ANDREW  
IN THE PROVINCE OF ALBERTA  
TO AUTHORIZE THE SET UP OF THE MILL RATE FOR  
THE PROPERTY TAXATION TO BE IMPOSED FOR THE YEAR 1997  
AND THE IMPOSING OF PENALTIES ON NON-PAYMENT OF TAXES**

**WHEREAS:** the estimated amounts of revenues and expenditures calculated by requisition, and by estimate, the 1997 budget is set as follows:

ASFF, Residential	55,679 Dollars	16.83%
ASFF, Non-Residential	38,791 Dollars	11.72%
County of Lamont Foundation	3,976 Dollars	1.20%
Municipal Government	232,440 Dollars	70.25%
TOTAL	330,886 Dollars	100.00%

**WHEREAS:** the total assessment valuation of land and improvements less the property exempted amounts to \$2,947,090 commercial and \$7,885,920 residential, plus \$215,180 seniors lodge,

**WHEREAS:** the rates hereinafter set out are necessary to provide the amounts required to meet the above mentioned purposes and after making due allowances for the amount of taxes which may reasonably be expected to remain unpaid for some time,

**THEREFORE:** by virtue of the power vested in the Council of the Village of Andrew in the Province of Alberta by the Municipal Government Act, being Chapter M26.1 of the Revised Statutes of Alberta enacts as follows:

**THAT:** the Municipal Administrator be and is hereby authorized to levy and collect the following rates of taxation on the assessed value of all land and improvements appearing on the current tax roll of the said Village, and

**THAT:** mill rate be imposed as such:

**THAT:** a penalty of 18.0% (per cent) will be applied on August 1, 1997 on unpaid current


taxes, and a further penalty of 18.0% (per cent) will be applied on January 1, 1998 on all unpaid taxes (current and arrears).
