VILLAGE OF ANDREW

THIS BYLAW BEING BYLAW 2001-01 OF THE VILLAGE OF ANDREW, IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF PROVIDING SPECIFIED NON-PROFIT COMMUNITY ORGANIZATIONS WITH AN EXEMPTION FROM MUNICIPAL TAXATION.

WHEREAS: Pursuant to Section 364(1) of the Municipal Government Act, Statutes of Alberta of Alberta, Chapter M-26.1 and the Community Organization Property Tax Exemption Regulation, AR 281/98, Council may pass a bylaw exempting from municipal taxation specified non-profit community organizations.

NOW THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE VILLAGE OF ANDREW IN THE PROVINCE OF ALBERTA DULY ASSEMBLED ENACTS AS FOLLOWS.

- 1 NAME : This Bylaw may be cited as the "Non-Profit Community Organization exemption By-law.
- 2. DEFINITIONS -
 - 2.1 "Assessor "means the person appointed as Assessor for The Village of Andrew.
 - 2.2 "Council" means the council of The Village of Andrew

3. EXEMPTION FROM MUNICIPAL TAXES-

- 3.1 The property or portions of the property occupied by the non-profit community organization listed in Schedule "A" are hereby exempted from municipal taxation if the organization:
 - a) submits an annual application to the CAO for exemption, and
- b) continues to meet the required criteria.
- 4. NUMBER AND GENDER REFERENCES:
 - 4 1 All references in this bylaw shall be read with such changes in number and gender as may be appropriate according to whether the reference is to a male or female person or a corporation or partnership.

5 ADDING QUALIFYING ORGANIZATIONS:

- 5.1 The Village Council may be resolution add non-profit community organizations to Schedule "A"
- 6. EFFECTIVE DATE:
 - 6.1 This BYLAW shall take affect on the day of the final passing thereof.
 - 6.2 Exemptions shall commence on January 1 st 2001.
