CALL TO ORDER: Mayor Leppek called the Regular Council Meeting of February 27, 2019 to order

ADOPTION OF

THE AGENDA: Deputy Mayor Lupul added a new item to New Business, item b transfer

from reserves.

DELEGATION: WILSON ZUKIWSKY

Mr. Zukiwsky came to talk about the eavestroughs on the Rainbow Club building

and the Museum. He said that they were deteriorated. He also said the snow

load

on both buildings needs to be removed. Council will look at putting eavestroughs on the Museum, but not the Rainbow Club as it is not the Villages building. The Village cannot remove the snow off the roofs. Deputy Mayor Lupul will look into what grants are available to help the clubs and give the information to them.

OPEN FORUM: The president of the Ukrainian Orthodox Church in the Village talked about the

snowbanks being put in front of the Church sidewalks. She brought pictures. She

says there is no access to the sidewalk.

A resident stated that his garbage was not getting picked up. He also said he was refused twice when he came in to the Village Office to pay his utility bill. He said he had a discussion with the CAO about the water charge for his property when he has a well, but the CAO clarified it was about the sewer charge as she knows he has a well. He asked why the owner of the property received a a letter about the utility bill for the property not being paid. The resident said

that

his bill is \$400.00. The CAO clarified that it is the registered property owners who get the notices as they are responsible for all bills for their property. The resident stated that he wasn't paying the bill because his garbage wasn't being picked up. Then he stated that he wasn't paying his bill because the Village doesn't have interac. Then he said Janice, he never did like her when she was a teenager. The CAO then cautioned council that if this conversation continued it would have to be closed to the public as it deals with personnel. The resident agreed. His next issue was about snowmobilers going through his yard. He wants the Village to put signs on his property. When asked why he doesn't put up his own signs he said he did but that the Village's faithful guy on the bobcat knocked it down. Again, the CAO advised council that this should go to a closed meeting as it deals with employee issues, under FOIP. It was moved to 13 a.

Another citizen asked that people who work for the Village be reminded about the distracted driving law. The CAO will bring it up at a staff meeting.
