Fire Chief Bo Moore and Deputy Fire Chief Scott Calder presented a report on Emergency Services throughout the County along with specific actioning statistics relevant to the Village of Andrew.

## **Specific statistics for the Andrew Fire District:**

Total of 41 calls for service. Of those 41 calls for service 12 of them originated within the village of Andrew. This total calls a 41 is an increase from 29 calls from 2022 but down from 61 calls in 2021. Our average members attending those events is 2.95 members per call and an average shoot time of 15.8 minutes for those 41 calls that Andrew was tasked to attend.
