Residents over the age of 18 can file nomination papers for the positions of Councillor or Mayor now until noon on [September 22, 2025](#). Candidate Packages can be picked up at the Village Office. If you wish to submit your nomination papers prior to nomination day, please call for an appointment.

The Village of Andrew will be holding a Municipal Election on [Monday, October 20, 2025](#), where voters will elect one Mayor and four Councillors.

COLES NOTES REMINDER: Nomination Day is on September 22, 2025. If you wish to run for Councillor or Mayor, you must submit your nomination papers by 12:00pm on September 22, 2025. Election Day is on October 20, 2025.

VILLAGE OF ANDREW PET BYLAW
2024-002

REMINDER:
ALL dogs MUST be registered with the Village Office every year.

Even if your dog is always kept indoors or in your yard they still need to be registered every year and have a dog tag.

If you have not registered your dog please do so immediately as the Bylaw Officer will be issuing fines for failure to comply in the amount of \$100.00.

The licensing fee for neutered dogs is \$20.00 and unaltered dogs is \$40.00.
